Section 4: Merchant Representation

As used in this provision, "covered telecommunications equipment or services" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment. Prior to making any open market GPC purchase, the merchant shall first review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) or on the GSA SmartPay website (<https://smartpay.gsa.gov/content/prohibited-vendor-list>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services". Conducting business with merchants who use telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, (or any subsidiary or affiliate of such entities); Video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities) is strictly prohibited

- A. Card holder (CH) provides this representation document to the vendor to complete, sign, and return to the CH.
- B. If a merchant represents "does not" and "will not" the CH can rely on the representation and make the purchase. Include representation with other transaction supporting documents and provide a copy of this vendor representation to DHA.GPC@health.mil
- C. If a merchant represents 'will' to question 1, CH must find an alternate merchant.
- D. If a merchant represents 'does' or 'unknown' to question 2, contact A/OPC for decision on whether Product Service Code is waived. If so, instruct Cardholder to purchase and code 889 as 889 ODNI. If not, CH must find another merchant.
